Sixth ICLARS Conference Córdoba (Spain) 11-13 October 2021

New conference dates

In view of the conditions and difficulties created by the current health crisis caused by COVID-19, the ICLARS Steering Committee and the Conference's Organizing Committee have decided to postpone the Sixth ICLARS Conference: Human Dignity, Law and Religious Diversity: designing the future of inter-cultural societies. The Conference will be held from **11 to 13 October 2021**.

The **venue** of the conference remains the same: the Palace of Congresses of Cordoba (Spain).

Structure of the conference. Accepted papers and panels

The structure of the conference remains in the same terms. The mornings shall be dedicated to **plenary** sessions by invited speakers; and the afternoons, to parallel or concurrent sessions where the participant's proposed papers and panels will be allocated.

It is not necessary to propose again the panels and papers which have already been officially accepted. However, both individual speakers and panel coordinators must **confirm, no later than October 31 2020**, their intention to keep their proposals and participate in the conference. If any individual speakers or panel coordinators wish to **modify** the title of their papers, or the members or general theme of their panels, they must also notify these changes **no later than October 31 2020**.

At a later stage we shall provide more information on the deadline for the final acceptance of papers and panels through registration to the conference.

As of October 2020, the organizing committee shall decide whether or not to open a new call for paper and panel proposals.



Registration

At the moment, the registration procedure is suspended. During the last quarter of 2020 the registration procedure will be reactivated, and new updated fees for both participants and accompanying persons will be published.

Registrations already formalized and paid will be considered valid and applicable to the new dates of the conference, whatever the amount that is set for the updated registration fee.
